7:20 4. Discussion and possible action on a proposed 8-lot Small Lot Subdivision at 14451 Nordhoff Street, Panorama City, CA 91402. The property is on the northeast corner of the intersection of Nordhoff Street and Wakefield Avenue. The case number is **VTT-74079-ST**. This case was approved by the city on 2017-09-11. The developer was Albert Gonzalez, Albert G LLC, represented by Oshin Tosounian. The case returned to the Planning Department action list on August 16, 2020. We still need clarification of the reason for reconsideration. [10m]

- 7:30 5. **Consideration and possible action regarding Los Angeles City Council file CF 20-0608 (David Ryu and Paul Koretz), which proposes the creation of an Inspector General's office with a focus on land development issues.** This proposal is in response to the ongoing FBI investigation and recent charges against former councilmembers Mitch Englander and Jose Huizar. - 7:50 7. **Consideration and possible action regarding the recent listing of the bank building property at 14400 Roscoe Boulevard for sale \$3.8 million.** This is an 0.62 acre flat rectangular lot, one plot over from the corner of Van Nuys and Roscoe Boulevards. It is zoned (Q)C2-1-CDO in a Tier 2 TOC (Transit Oriented Corridor). The price of \$6 million per acre is surprising. The listing describes the site as "an established, gentrifying area with numerous new developments underway nearby". For more information, see the listing. - 8:00 8. **Consideration and possible action regarding the status of the "9 bad bills" being rushed through the state legislature, all of which would prevent local control over some aspect of local land use and grant special rights to developers.** This committee has already recommended that the Board oppose SB 1120 and all other bills of this type and the Board has already acted to recommend the city oppose them. This agenda item is to inform the public about the bills so that people may take personal action, in whatever way they choose, to communicate with our elected representatives (Assemblyman Adrin Nazarian, State Senator Bob Hertzberg, and Governor Gavin Newsom (at your option) to ask that he NOT SIGN SB 1120 and the other bills if they are approved. Whether you support or oppose, please consider taking action on this issue. It will have a major effect on land use in Los Angeles. Information from last month's agenda about these bills:

In May this committee requested and the Board approved a request to the city and a Community Impact Statement in favor of city opposition to these state attempts to override city zoning and give developers by-right power to create large residential projects in many existing single family and low density neighborhoods. An example of bills under item 4 is San Francisco Senator **Scott Wiener's SB 1120**, which essentially kills single family zoning statewide. But there are more! The full list includes **SB 902, SB 995, SB 1085, SB 1120, AB 725, AB 1279, AB 2345, AB 3040, and AB3107**. This whole series of current bills are worse than Wiener's SB 50, which the City of Los Angeles opposed last year, and which community action succeeded in killing twice.

Council Process: The council gained its official city role upon certification by the Board of Neighborhood Commissioners on March 15, 2007. Everyone who lives, works or owns real property within the boundaries of the Panorama City Neighborhood Council, or who declares a Community Interest in the area and the basis for it, is a "stakeholder". All stakeholders are members of the Council. Stakeholders elect a Board of Directors to represent them. This Board is recognized as the decision-making entity by the City of Los Angeles. The current Board was elected on April 27, 2019. The next election is planned for April 24, 2021. While the Board is the official decision-making entity, meetings are conducted as much as possible in a town hall spirit. Committees are open to anyone with an interest in Panorama City. Panorama City's neighborhood council is much more than its Board, and it depends on

public participation for its success.

Posting Sites: California's open meetings law, the Ralph M. Brown Act, requires that meeting notices be physically posted at a regular location 72 hours in advance for regular meetings and 24 hours in advance for special meetings. The location must be accessible to the public seven days a week, 24 hours a day. That location is the outside steel doors of the Plaza Del Valle Community Room, Building G, 8700 Van Nuys Boulevard, Panorama City, CA 91402. This council is also required to follow the City of Los Angeles posting policy for Neighborhood Councils. That policy additionally requires that councils post agendas through the city's Early Notification System (ENS), post the agendas on the council's website (if one exists), and make an effort to send agendas by electronic mail (if such a list exists). This council posts agendas on its website, panoramacitync.org. This council uses the city's ENS mailing list as its agenda email list. You may sign up for the ENS agenda system at:

In addition to the Plaza Del Valle posting location, this council MAY post agendas at other locations within Panorama City. These may include: (1) Panorama City Branch Library, 14345 Roscoe Boulevard; (2) Panorama Recreation Center, 8600 Hazeltine Avenue; (3) Sepulveda Recreation Center, 8801 Kester Avenue; and (4) Casa Esperanza, 14705 Blythe Street. In addition to the ENS agenda list, this council MAY include agendas in its occasional informational emails. You can subscribe to the council's informational email list by sending your request to 'info@panoramacitync.org'. You can also sign up on the council's website. In order to respect our stakeholders' inboxes, messages to the informational email list will be sent at most once or twice a month. *The only way to assure that you will receive emailed agendas is through the ENS list.*
