Consideration and possible action on the draft revision of the City of Los Angeles Neighborhood Council Code of Conduct Policy that was proposed on July 19, 2021, by Raquel Beltran, General Manager of the Department of Neighborhood Empowerment (DONE), for adoption by the Board of Neighborhood Commissioners (BONC).

The proposed new Code of Conduct policy gives DONE the power to deny any board member and also any stakeholder who is a committee member the ability to participate in any way with a

Neighborhood Council, and to request BONC to permanently remove them if they are a board member. This power could be exercised immediately by the General Manager of DONE upon the receipt of ANY COMPLAINT, whether justified or not, by any person, including a member of the public, including anonymous complaints and complaints for actions allegedly committed at any time in the past, which the complainant decides are violations of a yet-to-be-adopted "Workplace Equity Policy". All Neighborhood Council board members (together and as individuals) are responsible for maintaining a safe 'workspace', which is any meeting or event that is being conducted by the Neighborhood Council or another city entity. The City Attorney will conduct a special workshop on these new rules at the Congress of Neighborhoods that will be held online on Saturday, September 25, from 8:00 am to 4:30 pm. Registration for that event will open on about September 1. Check the Congress website for information.

Council Process: The council gained its official city role upon certification by the Board of Neighborhood Commissioners on March 15, 2007. Everyone who lives, works or owns real property within the boundaries of the Panorama City Neighborhood Council, or who declares a Community Interest in the area and the basis for it, is a "stakeholder". All stakeholders are members of the Neighborhood Council. Stakeholders elect a Board of Directors to represent them. This Board is recognized as the decision-making entity by the City of Los Angeles. The current Board was elected on May 20, 2021 (half of the seats were elected to a new term, to 2025; the other half are continuing members, term to 2023). While the Board is the official decision-making entity, meetings are conducted as much as possible in a town hall spirit. Committees are open to anyone with an interest in Panorama City. Panorama City's neighborhood council is much more than its Board. It depends on public participation for its success.

Posting Sites: California's open meetings law, the Ralph M. Brown Act, requires that meeting notices be physically posted at a regular location 72 hours in advance for regular meetings and 24 hours in advance for special meetings. The location must be accessible to the public seven days a week, 24 hours a day. That location is the outside steel doors of the Plaza Del Valle Community Room, Building G, 8700 Van Nuys Boulevard, Panorama City, CA 91402. This council is also required to follow the City of Los Angeles posting policy for Neighborhood Councils. That policy additionally requires that councils post agendas through the city's Early Notification System (ENS), post the agendas on the council's website (if one exists), and make an effort to send agendas by electronic mail (if such a list exists). This council posts agendas on its website, panoramacitync.org. This council uses the city's ENS mailing list as its agenda email list. You may sign up for the ENS agenda system at: http://lacity.org/government/Subscriptions/NeighborhoodCouncils/index.htm

In addition to the Plaza Del Valle posting location, this council MAY post agendas at other locations within Panorama City. These may include: (1) Panorama City Branch Library, 14345 Roscoe Boulevard; (2) Panorama Recreation Center, 8600 Hazeltine Avenue; (3) Sepulveda Recreation Center, 8801 Kester Avenue; and (4) Casa Esperanza, 14705 Blythe Street. In addition to the ENS agenda list, this council MAY include agendas in its occasional informational emails. You can subscribe to the council's informational email list by sending your request to 'pcnc@empowerla.org'. You can also send a request on the council's website. In order to respect our stakeholders' inboxes, messages to the informational email list will be sent at most once or twice a month. *The only way to assure that you will receive agendas by email is through the ENS list.*
