The quorum is 3 Board members or Alternates. Public comments on agenda items will be heard when the item is considered. Public comments on other matters within the council's jurisdiction may be made during the Public Comment period. Public comments are usually limited to two minutes per speaker, at the discretion of the Chair. Action may be taken on any agenda item except Public Comment and announcements. Actions may be reconsidered only if a motion for reconsideration is adopted at the same meeting where the action was taken. You may request a copy of printed materials that are distributed at the meeting. You may record the meeting by audio, video or photographic means as long as it is not disruptive. Meeting notices and agendas are posted at the Plaza Del Valle Community Room and at other locations (see notes below). If you need translation, or accommodation for a disability, please call the city Department of Neighborhood Empowerment at least three business days in advance (213-978-1551, or toll-free 3-1-1). The city is a covered entity under Title II of the Americans with Disabilities Act. If you believe the council is not following the law or its own rules you may file a grievance in writing with copies to both the Chair and the Secretary. Please be respectful of others, even when you differ with them. Times shown in the agenda are only estimates. The sequence and time may be changed at the meeting.

3. **Public Comment** and announcements. (**Please limit to two minutes per speaker.**) Public comment on agenda items will be heard at the time the item is considered.
4. **Follow-up** on past items.
  - a. List of PC schools will be distributed prior to this meeting.
  - b As discussed at our last meeting, we are hoping that students from the leadership classes at Panorama HS and Vista MS will be able to assist with distributing the door-hangers which will explain how to request a ballot for the upcoming PCNC elections. The contact people are Angela Hyland-Fernandez, PHS Community School Coordinator, and Taryn Keyser, VMS Leadership Class Teacher, respectively.
5. **Reports** from Chair about meetings attended since our last meeting:

The Chair attended the Vista MS Coffee with the Principal meeting on 2/5/21. The counseling staff was introduced and they explained about the counseling groups and clubs available for students as well as office hours for students and parents to speak with them. The magnet school offerings at Vista MS and later Panorama HS were described. Parents were asked to fill out the School Needs Survey. The Covid-19 testing site has moved from Vista MS to Panorama HS.
6. **Discussion** and possible action on supporting the UTLA/LAUSD position on how and when to reopen in-person schooling.
  - a.UTLA's position is that the following 3 criteria must be met: LA County must be out of the purple tier, full vaccination access must be available for all school staff required to work in person, and procedures and protocols for Covid testing, physical distancing, PPE, classroom ventilation, isolation/quarantine procedures, and cleaning must be in place.
  - b.LAUSD Board of Education President, Kelly Gonez, has begun a petition urging the L.A. County Health Department to prioritize vaccinating school personnel immediately. Superintendent Austin Beutner has pointed out that vaccinating 25,000 employees would allow 250,000 preschool and elementary students to return to schools. **Council Process:** The council gained its official city role upon certification by the Board of Neighborhood Commissioners on March 15, 2007. Everyone who lives, works or owns real property within the boundaries of the Panorama City Neighborhood Council, or who declares a Community Interest in the area and the basis for it, is a "stakeholder". All stakeholders are members of the Council. Stakeholders elect a Board of Directors to represent them. This Board is recognized as the decision-making entity by the City of Los Angeles. The current Board was elected on April 2, 2016. While the Board is the official decision-making entity, meetings are conducted as much as possible in a town hall spirit. Committees are open to anyone with an interest in Panorama City. Panorama City's neighborhood council is much more than its Board, and it depends on public participation for its success.

**Posting Sites:** California's open meetings law, the Ralph M. Brown Act, requires that meeting notices be physically posted at a regular location 72 hours in advance for regular meetings and 24 hours in advance for special meetings. The location must be accessible to the public seven days a week, 24 hours a day. That location is the outside steel doors of the Plaza Del Valle Community Room, Building G, 8700 Van Nuys Blvd, Panorama City, CA 91402. This council is also required to follow the City of Los Angeles posting policy for Neighborhood Councils. That policy additionally requires that councils post agendas through the city's Early Notification System (ENS), post the agendas on the council's website (if one exists), and make an effort to send agendas by electronic mail (if such a list exists). This council posts agendas on its website, [panoramacitync.org](http://panoramacitync.org). This council uses the city's ENS mailing list as its agenda email list. In addition to the Plaza Del Valle posting location, this council MAY post agendas at other locations within Panorama City. These may include: (1) Panorama City Branch Library, 14345 Roscoe Blvd; (2) Panorama Recreation Center, 8600 Hazeltine Avenue; (3) Sepulveda Recreation Center, 8801 Kester Avenue; and (4) Casa Esperanza, 14705 Blythe Street.

In addition to the ENS agenda list, this council MAY include agendas in its occasional informational emails. You can subscribe to the council's informational email list by sending your request to 'info@panoramacitync.org'. You can also sign up on the council's website. In order to respect our stakeholders' inboxes, messages to the informational email list will be sent at most once or twice a month. *The only way to assure that you will receive emailed agendas is through the ENS list.*

**Americans with Disabilities Act (ADA):** As a covered entity under Title II of the Americans with Disabilities Act, the City of Los Angeles does not discriminate on the basis of disability and upon request, will provide reasonable accommodation to ensure equal access to its programs, services, and activities. Sign language interpreters, assistive listening devices, or other auxiliary aids and/or services may be provided upon request. **Agenda-related written materials:** The council may occasionally prepare supplementary information to the agenda ("agenda packets"). When this is done, the agenda packets are normally made available both to Board or committee members and to the general public at the start of the posted meeting. In compliance with Government Code section 54957.5, non-exempt writings that are distributed to a majority or all of the Board or

committee *in advance of a meeting* may be viewed by appointment at the Panorama City Neighborhood Council office, 14500 Roscoe Blvd, Suite 400, Panorama City, CA 91401, (818-714-2133) during normal business hours, or at the scheduled meeting. ### **Virtual Meeting Guidelines**

- ? Upon entry to the meeting, all participants will be automatically placed on ‘mute’ as to not disrupt the current speaker.
- ? The Chair will run the meeting as ‘close to normal’ as possible, limiting the amount of time individual speakers may hold the floor.
- ? If you wish to speak, do so by ‘Raising your Hand’, a feature the platform has, which enables the formation of a queue.
- ? The Board Secretary will recognize your place in the queue, by responding through the ‘Chat’ feature.
- ? The Chair will then call upon, in ‘first come first served’ order as recognized by the Secretary. Once called upon, the speaker must UNMUTE their audio to begin their statement.
- ? Disruptions to the meeting or abuse of these guidelines will result in the immediate removal.
- ? Public Comment will also adhere to the ‘Raise Hand’, ‘Enter the Queue’, ‘Be Recognized by the Chair’ format.
