10. Discussion and possible action on the request for a Community Design Overlay approval in conjunction with the plan to demolish existing improvements at the former Island Pacific Market at 8340 Van Nuys Boulevard, Panorama City, CA 91402, and to divide the space into two separate

retail locations. This item was tabled, as there was no representative from the project present.

11. Discussion and possible action on recommendations from the Education Committee that the Board authorize the Education Committee chair to write a letter of support for a STEAM High Ability/Gifted Magnet program that will incorporate a coordinated feeder program from Vista Middle School to Panorama High School. We would also urge Alta California, Noble, and Obama Elementary Schools to become part of this feeder program.

• Lorena Barillas spoke about the program's launch at Vista Middle School, where there is already sports magnet program. The program will hopefully help prevent brain drain on the community and keep quality students here; way to promote arts and sciences, as well as lessens bus ride. Motion to authorize Education Committee chair was motioned by Pamela Gibberman/seconded by Summer Bernard. <u>Motion passes</u> <u>unanimously with 14 YES</u>.

It was motioned by John DiGregorio to combine and approve agenda items 12-15 for various education and outreach for up to \$2,600 total; motion was seconded by Tony Wilkinson. Roll call vote was taken: Item passed: 11 YES/0 NO/3 Abstain (Adria Deliberto, John DiGregorio, Michael Hasz)/1 ineligible (Viviano Montes).

12. Discussion and possible action on recommendations from the Education Committee that the Board approve up to \$1000 to support the purchase of educational materials (e.g. notebooks, folders, pens, paper) from a vendor such as Office Depot for the Adelante Hombre Youth Summit that will be held at Panorama High School on Saturday, April 27, 2019 from 8:30 a.m. to 2:00 p.m.

13. Discussion and possible action on recommendations from the Outreach Committee that the Board approve up to \$300 to support the Panorama Recreation Center's Spring Egg Hunt with refreshments and supplies such as tablecloths.

14. Discussion and possible action on recommendations from the Outreach Committee that the Board approve up to \$300 to buy small a small branded giveaway to give to children at events, such as branded yoyos or silly putty.

15. Discussion and possible action on recommendations from the Outreach Committee that the Board approve up to \$1000 for miscellaneous election supplies, including printing flyers(most likely will not spend anything close to do this).

16. Discussion and Possible Action on formally supporting 'Bridge Housing' through the 'A Bridge Home' initiative by submitting a formal letter to our City Councilmember, the HENC Committee and the Mayor requesting that Panorama City be selected as a future location/site for this project.

• The main topic of the discussion is that we need to nudge CD6 to be active in this process and not let the committee make decisions on Panorama City's behalf. The Board is not qualified to recommend a location, but we should be actively consulted. John DiGregorio motioned to submit a letter to CD6, which was seconded by Tony Wilkinson. <u>Hand vote; motion passes unanimously with 14 YES</u>.

17. Discussion and possible action on recommendations from the Outreach Committee that the Board appoint a Liaison for Purposeful Aging to the LA City Department of Aging.

Julie Santos was introduced to the Board and expressed her interest and shared her qualifications. Marisa
Persaud motioned that we appoint Ms. Santos as PCNC's Liaison for Purposeful Aging to the LA City
Department of Aging; motioned seconded by John DiGregorio. <u>Voice vote; motion passes unanimously
with 14 YES</u>.

18. Discussion and possible action on recommendations from the Land Use Committee that the Board ask that the City Council take a position on additional state land use legislation that is pending in Sacramento. Each of these bills proposes to supersede local planning and zoning controls, similar to SB 50 (Weiner, Density Bonus) that the Board voted to oppose at its February meeting. The bills that will be considered by the Land Use Committee before the Board meeting include the following: SB 330 (Skinner), AB 725 (Wicks, Wiener, Skinner), AB 881 (Bloom), AB 1279 (Bloom), AB 1485 (Wicks), AB 1515 (Friedman), AB 1560 (Friedman, Gabriel), AB 1562 (Burke).

 John DiGregorio motioned to submit Tony Wilkinson's letter as presented, which was seconded by Marisa Persaud. <u>Hand vote; motion passes 13 YES/0 NO/1 Abstain (Summer Bernardo).</u> Tony will send letter as instructed.

19. Discussion and possible action to remove any board member(s) that have violated Article V, section 7 "Absences" of the PCNC By-Laws. <u>None at this time</u>.

20. Report from the NC Budget Advocates on progress and action items by the NCBA to date regarding the city budget process.

• John DiGregorio reported that he is looking for a space in the East Valley for the Budget Advocates Town Hall. Please let him know of any spaces.

21. Discussion and possible action for approval of any financial statements, Monthly Expenditure Reports (MER's), or other ongoing monthly financial documents prepared by the Treasurer or Finance Chair which have not yet been approved by the Board.
