Consideration and possible action on the reassignment of the entire LAPD Mission Division Gang Enforcement Detail because of reports of traffic stops that were out of policy, failure to properly activate body cameras, and allegations of possible property theft.** LAPD Mission Division, which serves Panorama City, Arleta, North Hills East, Mission Hills and Sylmar, had one of the largest gang units in the city (12 or 13 officers) and was one of the city's most active divisions for traffic stops. A new officer in charge and a new sergeant have been assigned to the Mission gang unit are beginning to rebuild it with carefully selected officers. Meanwhile other divisions and Valley Bureau are loaning officers to provide gang enforcement.

Consideration and possible action regarding the rise in gun crime and possession, especially by juveniles, and county and state court policies that discourage gun enhancements in criminal prosecutions.** The current District Attorney has a policy of refusing to add gun enhancements when prosecuting crimes in which a gun is used. With respect to that policy for juveniles, the DA's office has pointed out that state courts usually refuse to detain juveniles, even when a gun has been used in their crime.

Consideration and possible action on reports that the Los Angeles Unified School District has been "pushing out" (effectively expelling) young people from their schools at younger and younger ages.** Charter schools often refuse to take the students who are "pushed out" of regular schools. They end up in "store-front" alternative schools that require only a few hours of attendance per week, which gives the kids lots of free crime to spend in ganga and criminal activities.

Council Process: The council gained its official city role upon certification by the Board of Neighborhood Commissioners on March 15, 2007. Everyone who lives, works or owns real property within the boundaries of the Panorama City Neighborhood Council, or who declares a Community Interest in the area and the basis for it, is a "stakeholder". All stakeholders are members of the Council. Stakeholders elect a Board of Directors to represent them. This Board is recognized as the decision-making entity by the City of Los Angeles. The current Board was elected on April 20, 2021. The next election is planned for Spring, 2023. While the Board is the official decision-making entity, meetings are conducted as much as possible in a town hall spirit. Committees are open to anyone with an interest in Panorama City. Panorama City's neighborhood council is much more than its Board, and it depends on public participation for its success.

Posting Sites: California's open meetings law, the Ralph M. Brown Act, requires that meeting notices be physically posted at a regular location 72 hours in advance for regular meetings and 24 hours in advance for special meetings. The location must be accessible to the public seven days a week, 24 hours a day. That location is the outside windows or steel doors of the Plaza Del Valle Community Room, Building G, 8700 Van Nuys Boulevard, Panorama City, CA 91402. This council is also required to follow the City of Los Angeles posting policy for Neighborhood Councils. That policy additionally requires that councils post agendas through the city's Early Notification System (ENS), post the agendas on the council's website (if one exists), and make an effort to send agendas by electronic mail (if such a list exists).
