Consideration and possible action on a proposal for construction of a new two-story 15,468 square-foot retail / office building including 156 vehicular parking spaces and 16 bike parking spaces at 14541 West Terra Bella Street, Panorama City, CA 91402 and a Vesting Zone Change from [T][Q]C2-1VL to (T)(Q)C2-1VL for the portion of the site proposed for new construction. The case numbers are APCNV-2020-3302-ZC and ENV-2020-3303-MND. The applicant is Edmond Hagooli of Panorama Center I and II LLC.

Project Representative is Eric Lieberman and Gabriel Pena-Lora (gabriel@qesqms.com, 818-997-8033) of QES, Incorporated.

The project is located northwest of the intersection of Nordhoff Street and Terra Bella Street. It covers 5 adjacent lots in the same parking lot: APN: 2639-008-134, 9124-9132 N Van Nuys Blvd.; APN: 2639-008-025, 9100-9118 N Van Nuys Blvd, 14555-14557 N Van Nuys Blvd, 14551 W Nordhoff St; APN: 2639-008-135, 14541 W Terra Bella St, 14545 N Van Nuys Blvd; APN: 2639-008-011, No Address; APN: 2639-008-012, 14505,14515 W Terra Bella St.

The project will maintain all the existing on-site buildings. The new commercial building will occupy the southwestern portion of the existing surface parking lot. Existing common access driveways on the southwest to Van Nuys Boulevard and on the northeast to Terra Bella Street will be preserved. The driveway at the building site will be shifted northeast by way of a new curb cut. The Zone Change will effectively remove the permanent Q-conditions, allowing the proposed building configuration as well as additional actions including, but not limited to, grading, excavation, and building permits. Consideration and possible action on the final environmental impact reports (FEIS/FEIR) for the East San Fernando Valley Light Rail Corridor, including any community concerns related to this upcoming light rail project. The project will put a light rail system down Van Nuys Boulevard, running from the Sylmar Metro station to the Orange Line in Van Nuys. The maintenance yard will be built in Panorama City / Van Nuys, southwest of the Union Pacific railroad tracks. The comment period on the FEIS/FEIR has been extended. **Council Process:** The council gained its official city role upon certification by the Board of Neighborhood Commissioners on March 15, 2007. Everyone who lives, works or owns real property within the boundaries of the Panorama City Neighborhood Council, or who declares a Community Interest in the area and the basis for it, is a "stakeholder". All stakeholders are members of the Council. Stakeholders elect a Board of Directors to represent them. This Board is recognized as the decision-making entity by the City of Los Angeles. The current Board was elected on April 27, 2019. The next election is planned for April 24, 2021. While the Board is the official decision-making entity, meetings are conducted as much as possible in a town hall spirit. Committees are open to anyone with an interest in Panorama City. Panorama City's neighborhood council is much more than its Board, and it depends on public participation for its success.

**Posting Sites:** California's open meetings law, the Ralph M. Brown Act, requires that meeting notices be physically posted at a regular location 72 hours in advance for regular meetings and 24 hours in advance for special meetings. The location must be accessible to the public seven days a week, 24 hours a day. That location is the outside steel doors of the Plaza Del Valle Community Room, Building G, 8700 Van Nuys Boulevard, Panorama City, CA 91402. This council is also required to follow the City of Los Angeles posting policy for Neighborhood Councils. That policy additionally requires that councils post agendas through the city's Early Notification System (ENS), post the agendas on the council's website (if one exists), and make an effort to send agendas by electronic mail (if such a list exists). This council posts agendas on its website, panoramacitync.org. This council uses the city's ENS mailing list as its agenda email list. You may sign up for the ENS agenda system at:
