Council Process: The council gained its official city role upon certification by the Board of Neighborhood Commissioners on March 15, 2007. Everyone who lives, works or owns real property within the boundaries of the Panorama City Neighborhood Council, or who declares a Community Interest in the area and the basis for it, is a "stakeholder". All stakeholders are members of the Council. Stakeholders elect a Board of Directors to represent them. This Board is recognized as the decision-making entity by the City of Los Angeles. The current Board was elected on April 2, 2016. While the Board is the official decision-making entity, meetings are conducted as much as possible in a town hall spirit. Committees are open to anyone with an interest in Panorama City. Panorama City's neighborhood council is much more than its Board, and it depends on public participation for its success.

Posting Sites: California's open meetings law, the Ralph M. Brown Act, requires that meeting notices be physically posted at a regular location 72 hours in advance for regular meetings and 24 hours in advance for special meetings. The location must be accessible to the public seven days a week, 24 hours a day. That location is the outside steel doors of the Plaza Del Valle Community Room, Building G, 8700 Van Nuys Boulevard, Panorama City, CA 91402. This council is also required to follow the City of Los Angeles posting policy for Neighborhood Councils. That policy additionally requires that councils post agendas through the city's Early Notification System (ENS), post the agendas on the council's website (if one exists), and make an effort to send agendas by electronic mail (if such a list exists). This council posts agendas on its website, panoramacitync.org. This council uses the city's ENS mailing list as its agenda email list. In addition to the Plaza Del Valle posting location, this council MAY post agendas at other locations within Panorama City. In order to respect our stakeholders' inboxes, messages to the informational email list will be sent at most once or twice a month. The only way to assure that you will receive emailed agendas is through the ENS list.

The purpose and intent of the grant is to supply students within Neighborhood Council's boundaries with updated and functioning technology in their classrooms and for required state and federal computer-based academic testing in English language arts, math, reading, and science. These devices are required for the assessments given by the state of California.

NVMI College Prep Academy has technological devices that are incapable of maintaining a wireless connection and have to be reconfigured after a student uses them for any one project. Currently NVMI has less then 60 working laptops for the use of 600 NVMI students at any given time. With new devices, students would be able to complete projects, research papers, online blogging activities, assessments and testing without needing weekly repair and service from our technical support.

# 5) How will this grant be used to primarily support or serve a public purpose and benefit the public at-large. (Grants cannot be used as rewards or prizes for individuals)

This grant will be used to supply the students with updated modern technology. These devices need to have updated operating systems, educational application capabilities, secure browser capabilities (for the mandated testing assessments) and function within a WiFi network provided on campus. The current technology available is about 8 years old and a realistic lifespan of technology is about three years. We request the right to choose which devices are purchased. At the rapid rate that technology is upgraded and offered for sale, the best products for the best costs will need to be considered before we purchase the number of devices based on prices at the time of the actual purchase. Students using these devices will be able to transfer their technological skills to jobs within their neighborhoods, and use them at the colleges and universities they may attend. We also expect students to be able to use the devices to facilitate learning and improve their educational performance. NVMI serves 83 students that reside in Panorama City.
