The quorum is 3 Board members or Alternates. Public comments on agenda items will be heard when the item is considered. Public comments on other matters within the council's jurisdiction may be made during the Public Comment period. Public comments are usually limited to two minutes per speaker, at the discretion of the Chair. Action may be taken on any agenda item except Public Comment and announcements. Actions may be reconsidered only if a motion for reconsideration is adopted at the same meeting where the action was taken. You may request a copy of printed materials that are distributed at the meeting. You may record the meeting by audio, video or photographic means as long as it is not disruptive. Meeting notices and agendas are posted at the Plaza Del Valle Community Room and at other locations (see notes below). If you need translation, or accommodation for a disability, please call the city Department of Neighborhood Empowerment at least three business days in advance (213-978-1551, or toll-free 3-1-1). The city is a covered entity under Title II of the Americans with Disabilities Act. If you believe the council is not following the law or its own rules you may file a grievance in writing with copies to both the Chair and the Secretary. Please be respectful of others, even when you differ with them. Times shown in the agenda are only estimates. The sequence and time may be changed at the meeting.

*Present: Pamela, Severiana, Tony, Angela*  
*Guests: Jonathan Martinez, Luis Zapata*
3. **Public Comment** and announcements. **(Please limit to two minutes per speaker.)** *Public comment on agenda*  
 Items will be heard at the time the item is considered.  
*Angela announced that Panorama HS has been busy with homecoming activities and are getting ready for Halloween. Only one faculty member was not vaccinated by the deadline. About 40% of students have uploaded their vaccination info. They are using the 4X4 schedule for classes. They have been heavily impacted by the lack of substitutes since so many were assigned to City of Angels.*
4. **Follow-up** on past items.
  - a. If Michael Menjivar is able to attend, we may learn the status of our motion to urge the LAUSD Board of Education to adopt the "Arts ARE Education" Resolution. We also would like to know how much of the additional arts funding he mentioned at a previous meeting actually came to Panorama City schools.  
*Michael was not present.*
  - b. The Chair was made aware of increased difficulty and stress on teachers and administrators due to a lack of substitutes in LAUSD and also the effects of the coming enforcement of the vaccine mandate on all school personnel, and therefore made the determination to hold off on outreach for our student/legislator interaction until after the November 1<sup>st</sup> deadline had passed. We should continue to seek input about how to structure this, e.g, one class, multiple classes, by Zoom, in person, etc.  
*We discussed beginning with Angela's Student Council meeting on Mondays from 3:30-4:30 p.m. Angela invited Tony to come and speak with them about the importance of listening to different opinions and making choices and why they need to be involved with their community. Tony will attend PHS's faculty meeting to explain our project. Angela invited Severiana to participate in setting up an altar for Dia de los Muertos in the PHS auditorium foyer. The display would be available to view 10/28-11/5/2021*
  - c. The Chair and Severiana attended the LAUSD Superintendent Search Community Listening Session on Tuesday, September 28<sup>th</sup>. We each had the opportunity to offer our input along with many other members of the East Valley community.
5. **Discussion and possible action** on setting up a meeting with students and government representatives.  
*We agreed to let Tony meet with the students first, then bring in the legislators or their representatives.*
6. **Discussion and possible action** on creating a monthly flyer with info about upcoming opportunities for student/family interaction with local legislators to be made available on our website, school websites, and Parent Centers.  
*Tabled*
7. **Discussion and possible action** on a questionnaire developed at Panorama HS which could also go to Vista MS, GALS, St. Genevieve HS, Valor Academy Charter, and Valor Academy High.  
*Angela will share the questionnaire she has developed which has not yet been sent to the community.*
8. **Discussion** about items for the next meeting on **Monday, November 15, 2021.**  
*Continue working on Items 5 & 6.*

**Council Process:** The council gained its official city role upon certification by the Board of Neighborhood Commissioners on March 15, 2007. Everyone who lives, works or owns real property within the boundaries of the Panorama City Neighborhood Council, or who declares a Community Interest in the area and the basis for it, is a "stakeholder". All stakeholders are members of the Council. Stakeholders elect a Board of Directors to represent them. This Board is recognized as the decision-making entity by the City of Los Angeles. The current Board was elected on April 2, 2016. While the Board is the official decision-making entity, meetings are conducted as much as possible in a town hall spirit. Committees are open to anyone with an interest in Panorama City. Panorama City's neighborhood council is much more than its Board, and it depends on public participation for its success.

**Posting Sites:** California's open meetings law, the Ralph M. Brown Act, requires that meeting notices be physically posted at a regular location 72 hours in advance for regular meetings and 24 hours in advance for special meetings. The location must be accessible to the public seven days a week, 24 hours a day. That location is the outside steel doors of the Plaza Del Valle Community Room, Building G, 8700 Van Nuys Blvd, Panorama City, CA 91402. This council is also required to follow the City of Los Angeles posting policy for Neighborhood Councils. That policy additionally requires that councils post agendas through the city's Early Notification System (ENS), post the agendas on the council's website (if one exists), and make an effort to send agendas by electronic mail (if such a list exists). This council posts agendas on its website, panoramacitync.org. This council uses the city's ENS mailing list as its agenda email list. You can subscribe to the council's informational email list by sending your request to 'info@panoramacitync.org'. You can also sign up on the council's website. In order to respect our stakeholders' inboxes, messages to the informational email list will be sent at most once or twice a month. *The only way to assure that you will receive emailed agendas is through the ENS list.*

### **Virtual Meeting Guidelines**

- Upon entry to the meeting, all participants will be automatically placed on 'mute' as to not disrupt the current speaker.
- The Chair will run the meeting as 'close to normal' as possible, limiting the amount of time individual speakers may hold the floor.
- If you wish to speak, do so by 'Raising your Hand', a feature the platform has, which enables the formation of a queue.
- The Board Secretary will recognize your place in the queue, by responding through the 'Chat' feature.
- The Chair will then call upon, in 'first come first served' order as recognized by the Secretary. Once called upon, the speaker must UNMUTE their audio to begin their statement.
- Disruptions to the meeting or abuse of these guidelines will result in the immediate removal.
- Public Comment will also adhere to the 'Raise Hand', 'Enter the Queue', 'Be Recognized by the Chair' format.
